

# SCHOLARSHIP REPORTING

## Introduction

USDA National Institute of Food and Agriculture (NIFA) requires periodic reports on the 1890s scholarship program. These reports will include data that enable NIFA to report to the US Congress on the success and efficacy of the program that in turn enables congress to plan future bill allocations.

FAEIS, the Food and Agricultural Education Information System, is a federally mandated survey that compiles nationwide higher education data for the life, food, veterinary, human, natural resource, and agricultural sciences. These data include student enrollment, degrees awarded, transfer, and placement at all degree levels by gender and race/ethnicity. The Scholarship reports will be collected by FAEIS as an extension to this existing dataset to compliment broad picture answers.

# October 2020 Report

The first NIFA report is due by the end of October 2020. This report characterizes the distribution to the first year of scholarship recipients. FAEIS would also like to strengthen its baseline enrollment and degree information for each institution. FAEIS will send a separate request to verify 2016 – 2019 detailed student survey for your institution.
