College Profiles

FAEIS users are familiar with the MY REPORTS section of the data entry website. Recently we modified MY REPORTS to allow you to view this information for all the institutions in FAEIS. Just login to FAEIS, click on MY REPORTS, select an institution, and select a report. (NOTE: not all institutions in FAEIS have submitted data).

New Academic Disciplines and CIP 2010

Every 10 years the US Department of Education revises it's **Classification of Instructional Programs.** FAEIS uses "CIP 2000" codes to specify the disciplines for student and faculty data entry. New CIPs will be published in 2010, but they are already starting on the revisions!

If you have a program at your institution that can not be classified using the current CIP codes, please send this information to the <u>FAEIS Team</u> and we'll pass it on to our contacts at the USDA who will be participating in the CIP revision effort.

For example, **Viticulture** and **Organic Agriculture** are programs currently taught that do not ave matching CIP codes. As a consequence, these programs must be recorded under less specific disciplines, such as Plant Sciences or Horticulture. The result being, new and emerging disciplines may not be indicated in the data.
